Sir / Madam,

- 1. The election of the ParentsqRepresentative will be held on 08 May 16 at 1130 hrs in the School Auditorium. Nomination forms for the proposed election can be obtained from the school Main Office personally on any working day between 0900 to 1300 hrs / download from School Website www.sskapurthala.com. The rules for election are: -
 - (a) His/her son should have been in the school as a Boarder for a minimum of two years prior to election and should have at least one more year to study in the school after election.
 - (b) He/she should not have been a defaulter in payment of School dues.
 - (c) The parents of students of class XII are not eligible for election.
 - (d) The school staff members are not eligible for election.
 - (e) A Local guardian cannot contest this election.
 - (f) The tenure of the parentsqrepresentative member will be one year.
 - (g) The nomination form should be filled by the candidate himself.
- 2. Duly completed nomination forms from parents wishing to seek election are to reach the school office latest by 1300 h on 06 May 16.
- 3. Only Parents/Guardians (Registered) are permitted to vote.

NOMINATION OF PAPER FOR PARENTS REPRESENTATIVE FOR THE LOCAL BOARD OF ADMIONISTRATION OF SAINIK SCHOOL, KAPURTHALA

- 1. To be eligible for election as member of the Local Board of Administration, the parents should fulfil the following conditions: -
